Entry Information:

Entry Information Requirement: Competitors are responsible to include a copy of all USEF and USDF memberships for horse, owner, rider, trainer, and coach listed on entry form or pay non-member fees.

USEF Equine Vaccination Rule & Health Requirements: All horses entering the show grounds of a USEF licensed competition MUST be accompanied by documentation showing vaccinations for Equine Influenza Virus and Equine Herpes Virus (Rhinopneumonitis) within 6 months as well as have a current negative EIA/Coggins test (within 12 months). **This is mandatory for every horse entry. USEF Rule GR845**

Entry Cancellation: Cancellations accepted only in writing by mail or e-mail prior to or on the received by/closing date. Entire entry refunded minus the office fee. No Refunds for any reason after the Received by/Closing Date.

Late Entries: Late entries will be accepted after the received by/closing date if space is available, upon payment of an additional late fee.

Post Entries for: Entries will be accepted to fill scratches, up to the start of competition, if scheduling permits. No late entry fee will be required but will be required to pay a post entry fee in addition to the normal class fee.

Policy for Accepting Post Entries and Filling Scratches in classes: Must be eligible for class. Must have previously entered in competition as a competing or non-competing horse. Must register with secretary and put name on wait list.

Post entries in national classes will only be accepted to fill scratches in allotted time slots that are available ("allotted time" slots are determined by the Official schedule posted at the show office). Exceptions will be made when two or more competitors meet the same criteria and are deemed equal in priority status. Exceptions may also be made when conditions are created by weather or other natural disasters.

Para-Equestrian competitors and their horses are no longer exempt from USDF memberships. Para-Equestrian competitors will now be required to have a USDF participating membership or a USDF group membership or a Non-Member fee will apply. All horses will need a life or HID USDF membership.

Musical Freestyles: Music must be on good quality CD and must be presented in the show office at least 30 minutes before the first scheduled ride of each day. Sound checks will be scheduled. A copy of the verifying test must be submitted with a freestyle class entry.

Bridle Numbers: must be worn at all times when a horse is out of the stall being exercised, ridden, etc.

Show Management reserves the right to vary or add officials and refuse any entry for a cause; to disqualify any exhibitor and/or his or her horse for cause; to cause an exhibitor to forfeit his or her ribbons and winnings for cause; to return any entry and/or stall fee before or during the show for cause; all without being liable for damage or compensation. Show management reserves the right to make any changes deemed necessary for the safe and efficient conduct of this competition.

Cancellation prior to or on closing date - entire entry minus office fee. **Weather/Acts of God/Accidents or Emergency Policy:** Management reserves the right to cancel any classes due to hazardous weather, Acts of God, Accidents or Emergencies. Every effort will be made to reschedule with priority given USEF Program classes. No refunds for cancellations due to hazardous weather, Acts of God, Accidents or Emergencies.

No Refunds for any reason after received by/closing date. All fees collected on behalf of USEF/ USDF to be submitted to the Federation provided all outstanding show fees are paid in full; else it will be applied to those fees.

No Shows: All "No Shows" that have not contacted the show office will be considered a scratch for the rest of the show and time slots may be filled. Exhibitors enter with this understanding and agreement.

Stabling/Tack Stall: 224 Permanent stalls are 10' x 12' with doors, timber and steel with rubber mats. Tack stalls available only after all horses have been assigned a stall. Temporary stabling 10' x 10' with doors will be available, if entries warrant. If temporary stabling is utilized, barn assignments will be made based on postmark date of entry (not "stable with" requests). Please list the same name on all entries for a "stable with" group request. Specify Stallion, Mare, or Gelding. **ABSOLUTELY NO nails or screws permitted to be used in the stalls. SMOKING IS PROHIBITED IN THE STABLE AREA.** No electric or water hookups permitted from barns. Anyone changing stalls without permission from management will be assessed a fine of \$50.

Bedding: No bedding will be supplied. Shavings are available for purchase and order can be included with entry.

Non-Stabled Horses: There will be a grounds fee charge per horse per weekend in addition to other applicable charges.

Non-Competing Horses: Will be accepted upon payment of stabling or grounds fees, office fee and non-compete fee. Owners, riders and trainers must complete the entry form, including signatures, and submit along with a current negative Coggins.

Warning: Under the Equine Activity Liability Act, each participant who participates in an equine activity expressly Assumes the risks of engaging in and legal responsibility for injury, loss, or damage to person or property resulting from the risk of equine activities.

UNITED STATES DRESSAGE FEDERATION™ Regional Adult Amateur Equitation Program

The USDF Regional Adult Amateur Equitation Program recognizes adult amateurs competing in equitation and promotes correct seat, position, and use of the aids in dressage. An Adult Amateur Equitation Regional Final class will be held in conjunction with each of the nine USDF Regional Dressage Championship competitions, providing adult amateurs with additional opportunity for recognition.

Adult amateurs wishing to qualify to compete in an Adult Amateur Equitation Regional Final may do so by meeting the following requirements.

Qualifying Requirements

To be eligible for the USDF Adult Amateur Equitation Regional Final class, rider must have

- Earned a score of 70% or higher in any dressage seat equitation class (except walk/trot) at a USEF/USDF-recognized Dressage competition within the qualifying period of the applicable regional championship.
- OR
- Qualified to compete in any regional dressage championship class (excluding freestyles).

Membership Requirements

- Rider must have a USDF Participating Membership at the time the qualifying score is earned, and at the time of the Regional Final class.
- Rider must be an adult amateur, in accordance with GR1306 of the USEF rules, and be designated with USEF as an adult amateur when the score is earned, and at the time of the Regional Final class.
- Owner must have a USDF Participating or Business Membership when the qualifying score is earned, and at the time of the Regional Final class.
- Horse must have a USDF Lifetime Horse Registration when the qualifying score is earned, and at the time of the Regional Final class.

Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Preliminary Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A nonmember may participate as a handler, rider, driver, owner, lessee, agent, coach or trainer at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a \$45 Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot (exception: Friesian performance FR222) and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) NRHA Endorsed Reining Competitions. 8) Opportunity classes, 9) citizens of other nations who have proof, in English, of current membership in good standing of their own National Federation, 10) USEA beginner novice division; and 11) assistant handlers in Dressage Sport Horse Breeding classes.

Every effort will be made to reschedule with priority given to CDI or USEF Program classes. No refunds for cancellations due to hazardous weather, Acts of God, Accidents or Emergencies.

Important National Class Information:

- Amateur Classes (AA)** ○ Individuals possessing current amateur certification are only eligible as Adult Amateurs from the beginning of the calendar year in which they reach age 22.
- Only active United States Equestrian Federation members may obtain amateur status. (Exception: Equine Canada members in possession of current EC membership may sign for USEF Amateur status on a show by show basis at no cost).
 - Participants must possess current USEF Amateur status and qualify under the USEF Amateur rules. ○
 - If opportunity classes at Dressage Competitions are restricted to amateurs, riders are required to have an amateur status with USEF.

The Junior/Young Rider Classes (JR/YR)

Riders are eligible to compete in these classes until the end of the calendar year in which they reach the age of 21

The Pony division

For this competition, classes are offered from USEF Training Level through USEF Third level with classes designated for the JR/YR, the Adult Amateur, and the Open riders. The pony division is open to all breeds that meet the following measurement requirements. In the Dressage Division, a pony is an animal that does not exceed 148 cm (14.23 hh) without shoes, and 149 cm (14.27 hh) with shoes. The pony can be of any sex (Mare, Stallion, or Gelding).

- Ponies under the age of eight and in possession of a valid temporary card from another division or discipline should submit a copy with their entry.
- Measurement will be required for these pony specific classes if they do not currently have a valid measurement card.
- Measurement will be yearly beginning from the age of three (36 months) until the pony has reached the age of eight years. Animals three through seven years old will be issued an annual Temporary Certificate of Measurement and must be remeasured annually until the age of eight years. Animals eight years and older will be issued Standard Certificates of Measurement which will not need to be renewed. Measurement must be done on USEF Combined Driving and Dressage Pony Measurement form.
- Individual responsible for presenting the pony for measurement must be 18 years old. Animals submitted for measurement or re-measurement must show no evidence of lameness and must be jogged for soundness prior to the measurement. Animals showing evidence of lameness are not eligible for measurement or remeasurement.
- The pony must be entered to compete at the competition for a measurement to take place.
- When the competition veterinarian is on call and an alternative measurement time is necessary, management must receive a written request for measurement from the owner or agent at least five days prior to the start of competition to set up a time.

Opportunity Classes

Riders/Horses competing only in “opportunity” classes are exempt from USEF and USDF membership requirements and do not have to pay non-member (show pass), HID or USEF drug fees. In addition, owners, trainers & coaches are exempt from membership requirements for these classes. While membership requirements are waived for riders in “opportunity” classes all USEF Dressage Division rules apply (including dress & saddlery requirements) in addition to all applicable General Rules & Medications. “Opportunity” riders & horses may cross enter into non-opportunity classes, but if you do so all USEF/USDF membership requirements & fees will apply. Scores earned in “opportunity” classes may not be used toward USEF/USDF awards programs. **USEF rule GR821**

Horses are limited to a maximum of three Dressage rides per day at Fourth Level and below (including Rider Tests) or two Dressage rides per day above Fourth Level. Horses competing at both Fourth Level and Prix St. Georges, or their equivalents, are limited to two Dressage rides per day. Dressage Seat Equitation, Quadrille, Pas de Deux and Matiere classes are excluded from the maximum limit of rides per day and horses in these classes may compete at any level for which they are otherwise eligible during the same competition.

Consecutive Levels Horses may enter no more than two consecutive levels, Freestyle levels included, at any on competition.

Show Schedule and Ride Time Conflicts: It is the responsibility of the rider to inform the management of any time conflicts as soon as possible after receiving the schedule.

ARENAS: NEWLY REFURBISHED! The standard 20 X 60 meter arena will be used for all classes, except USEA Eventing classes, which will use a 20 X 40 arena unless specified different on the test. Riding within the dressage competition arenas is not allowed before the show at any time; however, riding around the perimeter of the arenas is permitted the day before the competition starts.

FOOTING: NEWLY REFURBISHED!! All weather footing in all rings

Current Rules: The rules may have changed from the current USEF Rule Book. It is the competitor's responsibility to check the current USEF Rule Book for any changes. Current rules can be found on www.usef.org.

Membership/Registration Requirements:

Riders/Owners/Trainers/Coaches must be current USEF members or a \$45 Non-Member Show Pass fee will apply. Riders/Owners must also be a member of the USDF (participating for GAIG/USDF qualifying) or a \$35 Non-Member fee will apply. Horses must have at least a USDF HID number (\$35) to show. For GAIG/USDF qualifying the horse needs a USEF life or annual membership and a USDF life membership. Horses with only an HID are not eligible.

Great American Insurance Group (GAIG)/USDF Qualifying Classes: Please indicate that the class is to count for qualifying by placing a Q after the class number on your entry. Qualifying does not require a separate ride. An exhibitor riding in the Open, AA or J/Y rider classes must pay an additional \$15 USDF fee to have this score entered in the GAIG/USDF qualifying division at that level.

Awards for USEF Classes: Divisions (Jr/Yg, AA, Open) may be run concurrently as one class. Divisions will be pinned separately. Riders must clearly specify division choice. When no designation is made, riders will automatically be entered as open. Riders may enter only one division per class. Ribbons to sixth for each class. No awards for Qualifying classes. Championship and Reserve ribbon awarded for the highest percentage at each USDF/USEF/FEI level on Saturday classes only.

Protective Headgear Rule: From the time horses are officially admitted to the competition grounds by competition management, anyone mounted on a horse at any time on the competition grounds including non-competing riders, riders on non-competing horses and those competing in all classes and tests must wear protective headgear as defined by this rule and otherwise in compliance with GR801. Any rider violating this rule at any time must be immediately prohibited from further riding until such headgear is properly in place. Protective headgear is defined as a riding helmet which meets or exceeds ASTM (American Society for Testing and Materials)/SEI (Safety Equipment Institute) standards for equestrian use and carries the SEI tag. The harness must be secured and properly fitted.

Important notice to all affected parties: Third parties may come upon the property or enter the facilities where any herein described or listed event will occur; provided, that this is a license to enter the premises, for the purpose of observing or participating in the event, but not otherwise, and such license to any individual is subject to revocation by the owner, lessee or organizer, and entry for any purpose other than granted herein, shall be deemed criminal trespass and subject to appropriate legal proceedings.

Sharps Disposal: Competition management may fine any individuals including trainers, owners, exhibitors, or their agents up to \$100 for improper disposal of needles or other sharp disposable instruments. Containers are located at the end of each barn aisle and within center aisles when center aisles are present within the barns.

Dogs: Facility rules require that dogs must be on a leash (not to exceed 6 feet in length) or suitably restrained in a tack stall/cage etc. Loose animals/animals left in vehicles in distress, etc. can and will be removed from the grounds at the owner's expense.

USDF Statement on Animal Welfare

The United States Dressage Federation, Inc. (USDF), a federation of over 100 independent organizations throughout the United States with a membership of nearly 30,000 members, supports the concept of ethical treatment of animals.

Dressage is a classical method of training horses, based upon the horse's natural responses, as carried out in a gradual, planned program during which the horse's athletic abilities are improved in a systematic manner. As a result, the horse becomes capable, comfortable, and responsive in partnership with the rider without the use of force. Dressage competition at various levels of achievement is the ultimate test of the training program to determine whether the desired harmony between horse and rider has been achieved.

The rules pertaining to dressage competition prohibit the use of artificial appliances, training aids, and drugs, which would force the horse to submit. Instead, the emphasis is upon training and a cooperative partnership with the rider. Major competitions are carefully monitored to assure that there is no unnecessary force or harshness displayed.

Unlike other horse sports in which horses enter training at a relatively immature state, dressage training is usually not seriously begun until the horse is three or four. The top levels of achievement require five or more years of progressive training and it is not unusual to see horses in international competition in their late teens. This, in itself, places a premium on good care and soundness throughout the horse's life.

While supporting the concept of animal welfare in its broadest form, the United States Dressage Federation, Inc., also recognizes that it is unrealistic to ascribe human emotions and responses to the horse which in its wild state is a creature of flight, living a hard and precarious existence. Under domestication, the horse is assured of ample food, water, and shelter, as well as protection against infectious diseases and damaging parasites, thus leading a longer and healthier life with a high rate of survival.

As an educational organization, USDF has numerous programs, which teach people how to pursue the accepted, humane training methods. A program of certifying instructors also emphasizes protecting the horse's welfare in pursuit of dressage training.

Penalties may include exclusion of the child, parent(s), guardian(s), and/or trainer(s) from the competition grounds for the remainder of the competition and charges being filed against any of the above individuals in accordance with Chapter 6. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

(the "Federation") and the local rules of the competition. I agree to be bound by the Bylaws and Rules of the Federation and of the competition. I will accept as final the decision of the Hearing Committee on any question arising under the Rules, and agree to release and hold harmless the competition, the Federation, their officials, directors and employees for any action taken under the Rules.

I represent that I am eligible to enter and/or participate under the Rules, and every horse I am entering is eligible as entered. I also agree that as a condition of and in consideration of acceptance of entry, the Federation and/or the Competition may use or assign photographs, videos, audios, cablecasts, broadcasts, internet, film, new media or other likenesses of me and my horse taken during the course of the competition for the promotion, coverage or benefit of the competition, sport, or the Federation. I hereby expressly and irrevocably waive and release any rights in connection with such use, including any claim to compensation, invasion of privacy, right of publicity, or to misappropriation.

Membership Requirements for USEF-licensed/USDF-recognized Competitions: Owners and riders, including foreign riders and owners who are not residents of the US, wishing to participate in a USEF-licensed/USDF-recognized competition as a rider or owner/lessee, must have either a USDF Group Membership (GM), Participating Membership (PM), or have a USDF Non-Member (NM) identification number and pay the USDF Non-Member (NM) fee. (Note: USDF Business Members can own horses but cannot compete as riders with their USDF Business Membership.) Individuals cannot compete at a USEF-licensed/USDF-recognized competition with a USDF Education Membership.

Horses competing at USEF-licensed/USDF-recognized competitions must have either a USDF Horse Identification (HID) number or a USDF Lifetime Horse Registration (LHR). Proper credentials or verification certificates must be presented to the competition secretary.

Riders and owners wishing to participate in a USEF-licensed/USDF-recognized competition, and not able to present the competition secretary with verification of a USDF membership or NM identification, and USDF LHR or USDF HID, must complete a USDF Competition Affidavit Form and pay the \$5 affidavit filing fee. A copy of a completed affidavit form from another competition may also be used for verification purposes for up to 60 days. (Exception: Affidavits cannot be used at Great American Insurance Group/USDF Regional Dressage Championships.)

Exceptions:

- Horses competing only in Individual Breed Classes (IBCs) at DSHB competitions, sires and dams of horses in DSHB group classes, where those sires or dams are not actually competing in the same competition, horses competing only in breed restricted dressage or DSHB classes at Regular Competitions (e.g. all Arabian, all Friesian, or all Morgan classes), or in USDF Introductory Level tests, pas de deux or quadrille, are exempt from this requirement. Also exempt are horses ridden in leadline, exhibitions, games and races, classes for 4-H members, walk-trot, academy, and opportunity classes.
- Riders and owners/lessees competing only in classes which are exempt from the USDF HID requirements are also exempt from the USDF NM identification number and NM fee requirements. Also exempt are handlers of horses competing in DSHB In-Hand or Group classes.

Memberships Defined

Participating Membership (PM): A membership issued to an individual directly by USDF. The membership year is December 1 through November 30. PMs are available for 1-year (\$90), 5-years (\$360), or life (\$1,800). A USDF Youth Participating Membership (YPM) is available for individuals who have not reached their 21st birthday by December 1 of the current membership year (\$72). A PM allows the member to compete at USEF-licensed/USDF-recognized competitions and to participate as a rider and/or owner/lessee for all Adequan®/USDF Year-End Awards, USDF Breeders Championship Series Finals and the Great American Insurance Group/USDF Regional Dressage Championship program.

Group Membership (GM): A membership issued to an individual by USDF when the member name and dues are submitted to USDF through an affiliate Group Member Organization (GMO). The GM year begins December 1 and ends November 30. A GM allows the member to compete at USEF-licensed/USDF-recognized competitions and participate in the USDF Rider Awards program.

Business Membership (BM): A membership that runs December 1 through November 30 and is issued to a business or organization directly by USDF. The USDF BM (\$240) offers a wider variety of advertising benefits. BMs satisfy requirements of horse ownership only.

Education Membership (EM): A membership issued to an individual directly by USDF. This online education only membership expires 12 months after the date joined. This membership type does NOT allow an individual to compete at a USEF-licensed/USDF-recognized competition.

Non-Member (NM) Identification Number: For each USDF NM owner/lessee and USDF NM rider there will be a USDF NM fee of \$35 per competition that must be collected by the show secretary and submitted to USDF, along with the USDF Report of Fees document and the \$5 affidavit fee and Competition Affidavit Form if the person cannot provide a copy of their USDF NM card. Owners/lessees or riders exempt from the NM number requirements are also exempt from paying the USDF NM fee. If there are multiple owners of a horse and all are NMs, only one of the owners must pay the NM fee. If the horse has at least one owner who is a current USDF PM, GM, or BM there is no NM fee assessed. Competition management will be invoiced for all applicable USDF NM fees not received with the USDF post-competition paperwork, along with a report listing all USDF NMs. Competition management is then required to submit the NM fees within 30 days to the USDF. An individual with a USDF NM identification number is not eligible for any USDF membership benefits. Once a USDF NM number has been assigned, a USDF NM card can be obtained from the USDF website.

Horse Identification (HID) Number: A one-time tracking number for horses (\$35). Scores earned by a horse with an HID number will be recorded, but will NOT be counted towards Adequan®/USDF Year-End Awards. A horse with an HID number is not eligible to compete in Great American Insurance Group/USDF Regional qualifying or championship classes or USDF Breeders Championship Series Finals. An HID number can be upgraded to a Lifetime Horse Registration (LHR) for a fee of \$80. If a horse has a USDF LHR it does not need an HID number. An HID number is a one-time fee that does not need to be renewed.

Lifetime Horse Registration (LHR): A horse with an LHR (\$115) is eligible for Adequan®/USDF Year-End Awards, and eligible to compete at USDF Breeders Championship Series Finals and Great American Insurance Group/USDF Regional qualifying and championship classes, assuming requirements for the owner and rider are met. If a horse has an LHR it does not need an HID number. An LHR does not need to be renewed.

In addition, Alaska and Hawaii may each hold state championships if an official request from a Group Member Organization (GMO) is received by April 1 of the prior year. Please refer to the 2018 USDF Member Guide for the comprehensive list of rules and requirements for this program.

Membership/Registration Requirements for Qualifying and Championships

All memberships and registrations/recordings must be correct and current at the time qualifying scores are earned and at the time of the championships.

Rider:

- ☐ Must have a USDF Participating* Membership (PM).
- ☐ Must have a USEF membership (Junior Active, Senior Active, or Life).

Horse:

- ☐ Must have a USDF Lifetime Horse Registration (LHR).
- ☐ Must have a USEF (Annual or Lifetime) Horse recording.
- ☐ USDF horse registration and USEF horse recording must be in the name(s) of the current owner(s) or lessee(s) of record. A horse is not required to have breed registry papers.

Owner:

- ☐ Must have a USDF Participating or Business Membership and a USEF membership (Junior Active, Senior Active, Life, or Recorded Farm (with Active Farm Owner)). If the horse has more than one owner, at least one owner must have both active USEF membership and active USDF Participating or Business Membership. For a business or farm to be the valid owner under this requirement, it must be listed as an owner of the horse with both USEF and USDF.

I **AGREE** to indemnify (that is, to pay any losses, damages, or costs incurred by) the Federation and the Competition and to hold them harmless with respect to claims for Harm to me or my horse, and for claims made by others for any Harm caused by me or my horse while at the Competition.

I have read the Federation Rules about protective equipment, including GR801 and if applicable, EV114, and I understand that I am entitled to wear protective equipment without penalty, and I acknowledge that the Federation strongly encourages me to do so while WARNING that no protective equipment can guard against all injuries.

If I am a parent or guardian of a junior exhibitor, I consent to the child's participation and **AGREE** to all of the above provisions and **AGREE** to assume all of the obligations of this Release on the child's behalf.

I represent that I have the requisite training, coaching and abilities to safely compete in this competition.

I **AGREE** that if I am injured at this competition, the medical personnel treating my injuries may provide information on my injury and treatment to the Federation on the official USEF accident/injury report form.
