Class Details, Fees, and General Information

- **Dressage Tests - Arena Size:**
 - Introductory Level (Classes 1-3 & 18) – Small Arena (20x40).
 - Training Level and Up (Classes 4-15) – Standard Arena (20x60).
 - Eventing Tests (Classes 16-17, 20-44):
 - Amoeba thru Preliminary A – Small Arena
 - Preliminary B, Intermediate, Advanced & FEI Tests – Standard Arena
- **Combined Tests** (Classes 20-28):
 - Includes Dressage and Show Jumping
 - Pre-Amoeba & Amoeba – USDF Intro Test A
 - Tadpole – USDF Intro Test B
 - Beginner Novice thru Adv. – USEF Eventing Test A
 - Show Jumping: Pre-Amoeba – 12”; Amoeba – 18”; Tadpole – 2’; Beginner Novice – 2’6”; Novice – 2’11”; Training – 3’3”; Preliminary – 3’7”
- **3-Phase** (Classes 41-45):
 - Amoeba – USDF Intro Test B; Show Jumping – 18”; XC – 12”, not timed.
 - Tadpole – USDF Intro Test C; Show Jumping – 2’; XC – 2’ at 300mpm.
 - Beginner Novice – USEF Beginner Novice Test B; Show Jumping – 2’6”; XC – 2’6” at 325mpm.
 - Novice – USEF Novice Test B; Show Jumping – 2’11”; XC – 2’11” at 400mpm.
 - Training/Novice – USEF Training Test B; Show Jumping – 3’3”; XC – 2’11” at 400mpm.
 - Includes one XC Schooling. Limited coaching permitted during XC competition.
- **Leadline Class:** Introductory Test A
- **Calling Tests:** Intro thru Fourth Level may be called. All CT/3Phase Tests may be called.
- **Cross-Country Schooling** (Class 51):
 - \$25 fee valid only with other class entry or pay regular \$50 schooling fee.
 - Amoeba thru Advanced XC jumps.
 - May ride Friday, Saturday or Sunday.
 - If only XC schooling (no other classes) - pay \$50 schooling fee plus stall or ship-in fee. No riding in arenas. No office fee needed.
- **Stabling:**
 - Overnight: \$40 per night, includes 1 bag shavings.
 - Additional Overnight: \$25 per night, no additional shavings.
 - Day Stabling: \$25 per day, show hours only, no shavings.
 - Tack Stall: \$25 per night, no shavings.
 - Please strip your stall before leaving.
- **Shavings:** \$7 per bag.
- **Ribbons:** Ribbons are awarded thru 6th place for each class. “Participant” ribbons are available for anyone not receiving a placing ribbon for Classes 1, 18, 20 and 30. Ribbons are available in the show office.
- **Ship-In Fee:** If not stabling, \$15 per day.
- **Non-Competing Horses:** \$15 Grounds Fee, either a Stall Fee or Ship-in Fee, and Office Fee.
- **RV/Camper Hookup:**
 - \$30 per day for 110V-20 amp
 - \$40 per day for 220V-30/50 amp
 - Includes overnight, water and electric
 - # of RV Hookups are limited. Assigned by postmark date.
- **Change Fee:** \$10 for any changes after entry submitted (e.g. rider or horse change, class changes, etc.)
- **Late Entry Fee:** A late entry is an entry postmarked, or received via email or fax, after the closing date. A late entry must include a \$25 late fee. Late entries accepted only if space allows.
- **Coggins:** Negative Coggins within 12 months required for all horses. Include with entry for each show.
- **Lunging:** No lunging in any of the arenas. Lunging permitted in any of the grass areas.
- **Entries:**
 - With each entry, include: 1) Entry Form; 2) Payment; 3) Coggins; 4) Poplar Place Farm Release; 5) GDCTA Release.
 - ***Accepted entries will be held responsible for all fees.***
- **Payment:**
 - Payment is due when entry is submitted.
 - Fax or email entries must include credit card information.
 - Checks payable to Poplar Place Farm, LLC.
 - We accept VISA, MasterCard, and Discover.
- **Ride Times:** Available Thursday PM before the show on website – www.poplarplacefarm.com
- **Refunds:**
 - Scratches received **in writing** (fax or email) by Tuesday midnight prior to show – full refund less office fee.
 - ***No refunds or credits after Tuesday for any reason.***
