## Class details and general information

### ➤ Dressage Tests – Arena Size

- Introductory Level (Classes 1-3) – Small Arena (20x40)
- Training Level and Up (Classes 4-15) – Standard Arena (20x60)
- Eventing Tests (Classes 20-26, 34-40)
  - Amoeba thru Preliminary A – Small Arena
  - Preliminary B, Intermediate, Advance, & FEI Tests – Standard Arena

### ➤ Combined Tests (Classes 20-26):

- Includes Dressage and Show Jumping
- Pre-Amoeba & Amoeba – USDF Intro Test A
- Tadpole – USDF Intro Test B
- Beginner Novice thru Prelim. \_ USEF Eventing Test A
- Show Jumping: Pre-Amoeba – 12”; Amoeba – 18”; Tadpole – 2’; Beginner Novice 2’6”; Novice – 2’11”; Training – 3’ 3”; Preliminary 3’ 7”

### ➤ 3-Phase (Classes 34-38)

- Amoeba – USDF Intro Test B; Show Jumping – 18”; XC 12”, not timed.
- Tadpole – USDF Intro Test C; Show Jumping – 2’; XC – 2’ at 300 mpm.
- Beginner Novice – USEF Beginner Novice Test A; Show Jumping – 2’6”; XC 2’6” at 325 mpm.
- Novice – USEF Novice Test A; Show Jumping – 2’11”; XC – 2’11” at 400 mpm.
- Training Novice – USEF Training Test A; Show Jumping – 3’3”; XC 2’11” at 400 mpm.
- Includes one XC Schooling before the event ONLY. Limited coaching permitted during XC competition.
- If you do not use the XC schooling before the event, you DO NOT get a credit for it and are NOT ALLOWED to use it after the event.

### ➤ Calling Tests: Intro thru Fourth Level may be called. All CT/3-Phase Tests may be called.

### ➤ Cross-Country Schooling:

- Amoeba thru Training XC jumps.
- May ride Friday or Saturday.

### ➤ Show Jump Schooling:

- Please return jumps to 2’6” height after schooling

### ➤ Stabling:

- Stall: \$45 per night, INCLUDES 1 bag of shavings.
- Tack Stall: \$35 per night, no shavings.
- Please strip your stall before leaving.

### ➤ Shavings: \$9 per bag

### ➤ Ribbons: Ribbons are awarded thru 6<sup>th</sup> place for each class. Ribbons are available in the show office. Medals awarded 1st-3<sup>rd</sup> place for Poplar Place Dressage Seat Equitation class.

### ➤ Haul-In Fee: If not stabling, \$20 per day.

### ➤ Non-competing Horses: \$20 Grounds Fee, either a stall fee or haul-in fee, and office fee.

### ➤ RV/Camper Spots:

- \$50 per day for 110V-20amp
- \$50 per day for 220V-30/50amp
- Includes overnight, water and electric
- Number of RV Hookups are limited. Assigned by postmark date.

### ➤ Change Fee: \$10 for any changes after entry submitted (e.g. rider or horse change, class change, etc.)

### ➤ Late Entry Fee: A late entry is an entry postmarked, or received via email or fax, after closing date. A late entry must include a \$50 late fee and full payment. Late entries accepted only if space allows.

### ➤ Coggins: Negative Coggins within 12 months required for all horses. Include with entry for each show.

### ➤ Lunging: No lunging in any of the arenas. Lunging permitted in the grass “lunging area,” located across from Ring 6.

### ➤ Entries:

- With each entry, include: 1) Entry form; 2) Payment; 3) Coggins if not on file; 4) Poplar Place Farm Release, if not on file; 5) GDCTA Release, if not on file.
- ***Accepted entry will be held responsible for all fees.***

### ➤ Payment:

- Payment is due when entry is submitted.
- Fax or email entries must include credit card information.
- Checks payable to Poplar Place Farm, LLC.
- We accept VISA, MasterCard, Amex and Discover

### ➤ Check-In: The office will open at 12 noon Friday before the show for check-in.

### ➤ Refunds:

- Scratches received **in writing** (fax or email) by Monday midnight prior to show – full refund less office fee. No voicemail withdrawals accepted.
